Mi Via Waiver Renewal

The Health Care Authority's (HCA) Developmental Disabilities Supports Division (DDSD) is pleased to announce that we have successfully submitted the Mi Via Waiver Application to the Centers for Medicare and Medicaid Services (CMS) on July 1, 2025. DDSD is requesting the Mi Via Waiver be renewed for another 5-year period with an effective date of October 1, 2025. CMS has 90 days to complete the review.

DDSD would like to thank everyone for their dedication and input as we went through the renewal process. Based on feedback provided during public comment DDSD eliminated the limits proposed on respite, community direct supports, and customized community group supports. We will notify you when the HCA receives an approval from CMS. The DDSD Mi Via Unit will now begin revising the New Mexico Administrative Code (NMAC) and the Mi Vi Service Standards to align with the waiver application. More information to come on opportunities for input.

Electronic Visit Verification (EVV) Update

The two new Mi Via Exception (E) EVV codes went live on January 25th, 2025.

The codes are as follows:

- Mi Via Exception Rate Homemaker Direct Support Employee- MVIA99509E
- Mi Via Exception Rate Respite-Employee - MVIAT1055SDE
- Employees who provide any of these two services **must** now clock in and out of each shift using the EVV system (AuthentiCare) Interactive Voice Response (IVR)
- Employees who provide any of the Mi Via services below **must** use EVV to clock in and out of each shift:
 - MVIA99509- Mi Via Homemaker/Direct Support – Employee
 - MVIA99509AC- Mi Via Homemaker/Direct Support – Vendor
 - MVIAT1005AC- Mi Via Vendor Respite
 - MVIAT1005SD- Mi Via Respite – Employee
 - MVIA99509E- Mi Via Exception Rate Homemaker Direct Support Employee

Behavior Support Consultation

Behavior Support Consultation is a Health and Wellness support provided by a Behavior Support Consultant (BSC). Behavior Support Consultation is available to help improve a participant's quality of life and help to support participants' family and support staff.

Behavior support consultation services are available to provide:

- Positive Behavior Support Assessments (PBSA)
- Plan development for Positive Behavior Support (PBSP) and treatment plans.
- Training provided to participants support system on PBSP and treatment plans.
- Support coordination with medical and other types of behavioral therapists.

Service is provided in a setting most comfortable for the participants as follows:

- Open setting
- Natural setting or,
- Clinical setting

Behavior Support Services help the participant and their support system to:

- Understand what may cause the participant's behavior.
- Come up with ways of redirecting the participant to positive behaviors.

HCA does not allow the use of restraints, restrictive interventions or seclusion of participants. Behavior Support Consultation does not provide behavioral health therapies or any other mental health services.
